



RCI PLUS TERMS AND CONDITIONS

Effective Date: 1 March 2024

RCI India Private Limited

1. These RCI Plus Terms and Conditions (“**RCI Plus Terms**”) are supplemental to any other terms and conditions regarding your applicable RCI membership. Unless otherwise stated herein, each term used in these RCI Plus Terms shall have the same meaning and definition assigned thereto in the existing terms and conditions governing your applicable RCI membership. For clarity, these RCI Plus Terms will prevail over your RCI membership terms and conditions in the event of any conflict in provisions.
2. RCI Plus Program Amendments or Termination. RCI may at any time, in its sole and absolute discretion, amend or terminate the RCI Plus program or part thereof. RCI may amend these RCI Plus Terms at any time in its sole discretion. The aforementioned amendment or termination shall be effective upon publication on www.RCI.com.
3. **Eligibility**
 - 3.1. Types of Eligible Members. With effect from 1 March 2024, the following members of RCI India Private Limited (“**RCI**”) may request (subject to approval by RCI in its sole and absolute discretion) for an upgrade to RCI Plus:
 - 3.1.1. Standard members of the RCI Weeks; and
 - 3.1.2. Platinum members of the RCI Weeks.
 - 3.2. RCI Plus Fee. RCI Plus membership shall be subject to member paying RCI the prevailing RCI Plus fee as charged by RCI from time to time.
 - 3.3. RCI Plus Term. This RCI Plus Term shall be in effect for a period of up to two (2) years commencing from the sign-up date by member to RCI Plus, and shall automatically terminate upon the completion of the term without the need for further notice or action by either party.
4. **Membership Benefits**. Subject to paragraph 2 above, for the duration of their respective RCI Plus memberships, each RCI Plus member may enjoy the following benefits (to the exclusion of all other benefits not expressly set out below):
 - 4.1. Exchange Protection (Formerly known as Flexible Exchange). Complimentary Exchange Protections allowing RCI Plus member to cancel or amend a Confirmed Exchange up to a certain number of calendar days before check-in date and receive a credit (which may be full or partial) to member’s account for the Exchange Trading Power and prevailing RCI Exchange Fees. For details, please refer to the Exchange Protection terms and conditions;
 - 4.2. Guest Certificate. Complimentary RCI Guest Certificates, provided that the Guest Certificates are not transferred or used for any commercial or monetary purpose, including but not limited to any auction, rental or sale, and the use of any Guest Certificate is subject to any conditions, restrictions or limitations which may be imposed by the Affiliated Resort or Inventory Provider;
 - 4.3. (RCI Weeks Only) Combine Deposits – 12 Months. Applicable only when a Combined Deposit is required to facilitate and complete an exchange booking made through the RCI call centre, complimentary combination of Deposits or Deposit Credits for use in holiday exchanges within twelve (12) months travel window from the date of combination. In the event that the exchange booking is cancelled or refunded, the Deposit combination shall also be void;
 - 4.4. (RCI Weeks Only) Deposit Extension. Applicable only when a Deposit Extension is required to facilitate and complete an exchange booking made through the RCI call centre, complimentary extension of the validity of Deposits for up to six (6) months from original validity date. In the event that the exchange booking is cancelled or refunded, the Deposit extension shall also be void;
 - 4.5. (RCI Weeks Only) Deposit Restore. Complimentary Deposit Restore allowing RCI Plus member to deposit a timeshare accommodation use rights up to 180 days in advance of the start dates of such use rights and receive the full Deposit Trading Power for such use rights;
 - 4.6. Priority Access. Select specially acquired holiday inventory, as determined in RCI’s sole and absolute discretion, may be made exclusively available for Exchanges by RCI Plus members before the inventory is made available to other RCI members;
 - 4.7. Rental Discount. RCI Plus members are eligible to receive a ten percent (10%) discount off the regular price of all Extra Vacations getaways (Bonus and rental). No two offers can be combined.
 - 4.8. Discount on Standard Exchange and Split Week Exchange.

 - 4.9. Complimentary Unit Upgrades and Changes. The following upgrade or change benefits are subject to availability and are not guaranteed. Complimentary unit upgrade no sooner than fourteen (14) days prior to check-in for Exchange bookings. Complimentary change in resort for Exchange provided that (a) such change request may only be made fourteen (14) to three (3) days prior to check-in, (b) requested substitute resort must be within the same area (as determined by RCI in its sole and absolute discretion) as originally-booked resort, (c) unit at the requested substitute resort must be the same size or larger than the originally-booked unit, (d) start date of the stay at the substitute resort must be within two (2) days of the originally-booked start date, (e) the length of stay for both original and substituted bookings must be identical, (f) upgrades and changes can only be made via the RCI call centre;
 - 4.10. Complimentary Holiday Entitlement. For every 2 (two) paid holidays booked within one calendar year through RCI, excluding hotel bookings, you are entitled to receive 1 (one) complimentary domestic exchange holiday through

RCI ("**Complimentary Holiday**"), subject to availability. For the avoidance of doubt, a domestic exchange holiday refers to an exchange holiday within the borders of India:

- 4.10.1. The Complimentary Holiday benefit is intended for personal use only and may not be transferred, rented or sold. It should be used in accordance with all applicable laws, regulations, and ethical standards. RCI reserves the right to verify the intended use of the Complimentary Holiday;
 - 4.10.2. In the event of the cancellation of any of the initial paid holidays for which you earned the Complimentary Holiday, RCI reserves the right to cancel the Complimentary Holiday;
 - 4.10.3. In the case of any chargebacks related to the Complimentary Holiday, RCI reserves the right to recover any associated costs or value of the Complimentary Holiday from the RCI Plus member;
 - 4.10.4. The Complimentary Holiday must be booked and used within 6 months from the date of booking of the second paid holiday, and within the RCI Plus Term. Failure to use the entitlement within this timeframe may result in the forfeiture of the Complimentary Holiday;
 - 4.10.5. Please note that Complimentary Holidays can only be booked via the RCI call centre;
 - 4.10.6. RCI reserves the right to modify or terminate this Complimentary Holiday Entitlement at its discretion, with or without notice, and such changes will be communicated to the members accordingly.
- 4.11. Hotels – Weeks + Cash. Subject to availability, access to hotel bookings with the use of Weeks plus cash; and
- 4.12. Hotels – Cash Store. Subject to availability, access to hotel bookings with cash only;
5. **Benefits Terms and Conditions**. For the avoidance of doubt, the access to and use of benefits set out under clause 4 above may be subject to other terms and conditions as issued by RCI from time to time.
- 5.1. RCI reserves the right to modify or limit any benefit specified under clause 4 at any time without prior notice and may do so in the event of misuse or abuse, as determined at the sole discretion of RCI.
